## Vita breve

Kai Ambos studied law and politics at the Universities of Freiburg, Oxford (UK) and Munich from 1984 to 1990. He passed his First State Examination (*Erstes Staatsexamen*) in law at Munich University in 1990 and the Second State Examination (*Zweites Staatsexamen*) for admittance to legal practice and judiciary) in the state of Baden-Württemberg in 1994. He obtained his Dr.jur. from Munich University in 1992, where he also completed his *Habilitiation* (post-doctoral qualification to obtain a full Professorship) in 2001.

Ambos holds, since May 2003, the Chair of Criminal Law, Criminal Procedure, Comparative Law, International Criminal Law and Public International Law at the <u>Georg-August-University</u> <u>Göttingen</u>, Germany. Previously he worked, inter alia, at the Max-Planck Institute for Foreign and International Criminal Law, Freiburg, Germany and has been involved in the Criminal Justice Reform in Latin America and Eastern Europe since then. He served as a Judge at the <u>Provincial Court (Landgericht) of Lower Saxony</u> in Göttingen from 24 March 2006 to 7 February 2017 (from January 2015 to 30 September 2015 delegated to the <u>Appeals Court (Oberlandesgericht) Braunschweig</u>); with his appointment as Judge at the <u>Kosovo Specialist Chambers</u> (KSC), The Hague, on 7 February 2017 he took leave from this judicial position. On 6 December 2017 he has been appointed as Advisor (*Amicus Curiae*) to the Colombian Special Jurisdiction for Peace. On 17 September 2018 he received the price "<u>Orden Carlos Lemos Simmonds</u>" for his involvement in the Colombian peace process. He is also list Counsel at the International Criminal Court. On 17 November 2020 he received the Wissenschaftspreis Niedersachsen which is the highest academic award in this Federal state. Since June 2021 he is a permanent Visiting Professor at the Law Faculty of the University of Lisbon (Portugal).

Judge Ambos is also since December 2013 Director of the <u>Centro de Estudios de Derecho Penal</u> <u>y Procesal Penal Latinoamericano</u> (CEDPAL) of Georg-August-Universität Göttingen. He serves as Editor-in-Chief of <u>Criminal Law Forum</u> (Springer, Society for the Reform of Criminal law) and, in different capacity, as member in various editorial boards of national and international journals, for example, <u>Goltdammer's Archiv für Strafrecht</u>, <u>International Criminal</u> <u>Law Review</u>, <u>L'Indice Penale</u>, <u>Revista Penal</u>, <u>Revista Portuguesa de Ciência Criminal</u>, <u>Zeitschrift für internationale Strafrechtsdogmatik</u>, <u>ELTE Law Journal</u>, <u>Journal of Criminal</u> <u>Law</u>. He is general coordinator of the Anglo-German Dialogue on '<u>Core Concepts in Criminal</u> <u>Law and Justice</u>' and general editor of the three volumes product of this dialogue to be published by Cambridge University Press.

He was Senior Research Fellow, Institute for Advanced Studies, Hebrew University, Jerusalem, Winter Semester 2011/2012; Fellow Faculty of Law and Clare Hall College, University of Cambridge, UK, April to August 2016 (Life Member of <u>Clare Hall College</u> since then); Plumer Fellow St. Anne's College and Visiting Fellow, Centre for Criminology, University of Oxford, UK, 1 August to 20 September 2017. Fellow <u>Wissenschaftskolleg zu Berlin</u>, academic year 2022/2023; Visiting Professor in China, Latin America (Argentina, Brasil, Chile, Colombia, Ecuador, Mexico, Peru), Spain, Italy and Israel.

His main research lies in criminal law and procedure, comparative law, international criminal law with a regional focus on Latin America, Portugal, Spain and Eastern Europe.
