## Supervision agreement according to § 5 para. 3 of the PStO 2024

**7** Every scientific activity is based on the principles of good scientific practice. practice, as formulated in the guidelines of the University of Göttingen, among others (<u>https://www.uni-</u> goettingen.de/de/ombudsstelle+f%C3%BCr+good+scientific+practice/223832.html).

**8.** in the event of conflicts between a supervisor and the doctoral candidate, the other members of the supervisory committee and the responsible committees and officials of the faculty shall mediate first. The Executive Board of the Graduate School can then be called upon; the responsibility of other committees, in particular the ombudsman committees of the University of Göttingen, remains unaffected.
