GVBI. p. 69), last amended by Article 7 of the Act of 23.03.2022 (Nds. GVBI. p. 218); § 63 h section 2 sentence 1 in conjunction with § 41 section 2 sentence 2 NHG; § 37 section 1 sentence 3 NHG in conjunction with § 1 sentence 3 of the Ordinance on the Implementation of the Scholarship Program Act (StipV) of December 20, 2010 (BGBI. I p. 2197), last amended by Article 2 of the Ordinance of November 29, 2011 (BGBI. I p. 2450); § 63 b sentence 3 NHG in conjunction with § 1 sentence 3 StipV).

Guideline of the Georg-August-Universität Göttingen/ Georg-August-Universität Göttingen Foundation under Public Law for the Awarding of Scholarships within the National Scholarship Programme (Germany Scholarships) - StipRiLi -

§ 1 Scope; Purpose of the scholarship; Transparency requirement

(1) The provisions of this guideline apply to the awarding of scholarships within the framework of the national scholarship programme of the Federal Government (Germany Scholarships) in accordance with the provisions of the Act on the Creation of a National Scholarship Programme (Scholarship Programme Act - StipG) and the Regulation on the Implementation of the Scholarship Programme Act (Scholarship Programme Regulation - StipV).

(2) The purpose of the scholarship is to support talented students who are expected to achieve or have already achieved excellent results in their studies or profession by the Georg-August-Universität Göttingen / Georg-August-Universität Göttingen Foundation under Public Law (both hereinafter: University of Göttingen).

(3) The principles of the selection procedure shall be made transparent to the private sponsors and the students.

§ 2 Eligibility for funding

¹According to the provisions of this guideline, funding is available to anyone who is enrolled at University of Göttingen as a student of any subject and who has a student account at the University of Göttingen. ²Doctoral students are excluded, even if they are enrolled in a doctoral programme or a doctoral degree programme.

§ 3 Type and scope of funding

(1) ¹The scholarship amount is usually 300 euros per month as a non-repayable grant. ²The scholarships are awarded for one year. ³The funding period begins in the respective winter semester.

(2) The scholarship may neither be made dependent on a consideration for a private funder nor on an employment relationship or a declaration of intent regarding a later employment relationship.

(3) ¹There is no legal entitlement to the scholarship and the scholarship payment. ²The scholarship does not constitute an employment relationship with the University of Göttingen. ³It is not subject to compulsory social insurance because it does not constitute remuneration according to § 14 SGB IV. ⁴The scholarship is tax-exempt under the conditions of § 3 no. 44 ESTG.

(4) Scholarships are awarded irrespective of income.

§ 4 Maximum funding period; Special provisions

(1) Students who are eligible to apply and receive funding are those who

- a) have not exceeded the standard period of study of the degree programme or partial degree programme for which the application is being made at the time of application, whereby the basis for assessment is the number of subject semesters, and
- b) are not on leave of absence at the beginning of the grant period.

²If there is an important reason, in deviation from sentence 1, anyone who has exceeded the standard period of study by a maximum of two subject semesters is entitled to apply; an important reason exists in the case of effects that extend the period of study:

- a) the care and upbringing of children within the meaning of § 25 section 5 BAföG,
- b) a disability or serious illness,
- c) a criminal offence of which the student was a victim,
- d) the overlapping of compulsory and elective compulsory courses in degree programmes of different partial degree programmes and faculties,
- e) the care of a close relative in need of care according to a report by the Medical Service of the Health Insurance Fund,
- f) simultaneous enrolment in the degree programme "Master of Education" and in the

extension degree programme "Third subject (teaching profession)", provided that achievements amounting to at least 22 credits in the extension degree programme are proven.

³Circumstances leading to an extension of the period of study may not be taken into account if the student was granted leave of absence due to these circumstances. ⁴The eligibility for funding shall cease as soon as the eligibility to apply lapses and the standard period of study is extended by more than one subject semester; in the case of sentence 2, the period shall be extended accordingly by up to two further subject semesters.

(2) Deviating from section 1, the scholarship shall also be paid in the following cases:

- a) periods of leave of absence for a study visit abroad within the meaning of the Regulations for Enrolment (ImmaO) of the University of Göttingen;
- b) periods during which employment is prohibited in accordance with the provisions of the Maternity Protection Act (Mutterschutzgesetz), provided the student is not on leave of absence during this period in accordance with § 9 ImmaO;
- c) lecture-free periods.

§ 5 Duties of cooperation

(1) Applicants must fulfil the duties of cooperation required for the selection procedure, in particular, they must provide the information required for the verification of the prerequisites truthfully and completely and provide the required proof.

(2) By accepting the scholarship, the scholarship holder commits himself/herself:

- a) to immediately report any changes that are relevant for the granting of the scholarship,
- b) to provide the University of Göttingen with the data required for the fulfilment of its duty to provide information pursuant to § 13, section 2, no. 1, section 4 StipG.

(3) ¹With the acceptance of the scholarship, the scholarship holder declares his or her willingness to participate in events within the framework of the scholarship programme; there is no obligation to participate. ²The University of Göttingen shall promote the contact of scholarship holders with private sponsors in a suitable manner. ³A scholarship holder is not obliged to make use of offers to maintain contact with private sponsors.

§ 6 Procedural principles

(1) The Presidential Board announces the scholarships once a year on the following website of the University of Göttingen for the winter semester, including the announcements required by the Scholarship Programme Act:

www.uni- goettingen.de/Deutschlandstipendium.

(2) Applications are open to those who

- a) fulfil the admission requirements necessary for the degree programme and
- b) are about to start studying at University of Göttingen or are already enrolled there

and have a student account.

(3) An application is only valid for the award of scholarships of the respective award procedure. The University of Göttingen is not obliged to check the applicants' details ex officio.

(4) Applications that do not comply with the provisions of the respective call for applications, in particular those that are not complete, in due form or on time, are excluded from the further procedure. Submitted documents remain with the university and are destroyed one year after the end of the process.

§ 7 Procedure of the application and selection process

(1) ¹A selection procedure takes place each winter semester. ²An applicant may only apply within the framework of one degree programme or partial degree programme. ³Application is only permitted within the framework of a degree programme or partial degree programme for which the applicant has applied in due form and time as a first-year student or for which he or she is enrolled. ⁴Updating of the online application in accordance with section 2 and the documents submitted is possible until the end of the application period; only complete documents submitted by the deadline will be considered.

(2) ¹The application must be submitted via an online portal. ²If the online application according to sentence 1 it is not possible due to a case of hardship, the application may be submitted in writing or by recording it at the faculty administration of the faculty that is responsible for the degree programme or partial degree programme within which the application is made (hereinafter: responsible faculty); the faculty administration must record the applicant's information in the online application system without delay.

(3) ¹The information in the online application must be supported by suitable documents, which are also generally to be uploaded to the university's server using the online portal in accordance with section 1 sentence 1, in particular evidence of:

- a) the university entrance qualification (e.g. grammar school leaving certificate), passed coursework or examinations as well as degrees;
- b) Awards, prices, previous professional activity or internships;
- c) extracurricular involvement such as voluntary work, social, university or political involvement or participation in religious societies, associations or clubs;
- d) special personal or family circumstances such as illnesses and disabilities, caring for one's own children, especially as a single parent, or close relatives in need of care, working in the family business, gainful employment while studying, family background or a migration background.

²Documents in a language other than German or English must be submitted in a certified German translation. ³On request, original proofs must be submitted. ⁴If a stated criterion in the online application is not proven by means of suitable documents, it will not be considered in the selection decision.

(4) ¹The scholarship holders shall be selected in a main procedure and, if necessary, in a subsequent procedure. ²If the number of applicants exceeds the number of scholarships to be awarded, a ranking list shall be drawn up for the selection. ³The selection decision shall be made according to talent and performance in combination with criteria of the following groups:

- a) special activities (appendix 2),
- b) social engagement (appendix 3) and
- c) special circumstances (appendix 4).

(5) ¹For the preparation of the ranking list, a procedure grade is determined for each candidate. ²The procedure grade results from the initial grade (appendix 1), which is improved as follows. ³For each proven criterion listed in appendices 2-4, the initial mark is improved by the value listed in appendices 2-4, but in the case of proof of several criteria of the group

- a) "special activities" by a maximum of 0.2,
- b) "social engagement" by the value 0.4,
- c) "special circumstances" by the value 0.4;

criteria that have already been taken into account in determining the maximum funding period, the eligibility to apply or the eligibility for funding may also be taken into account. ⁴If there is equality of rank after the ranking list has been drawn up, the ranking shall be determined by the result of the initial grade; thereafter, in the event of equality of rank, the decision shall be made by lot. ⁵As a prerequisite for eligibility for funding, it may also be stipulated in appendix 1 that proof be provided of the successful completion of a certain minimum amount of coursework and examinations; the information on the "subject semester" and "proof of special coursework and examinations" stipulated in appendix 1 shall refer to the winter semester for which the start of funding is applied for. ⁶Appendices 1-6 may be amended by resolution of the member of the Presidential Board for Studies and Teaching, unless otherwise stipulated, and shall be published in the amended version in the Official Announcements I.

(6) ¹Scholarships shall be awarded separately by faculty and, if necessary, separately by degree programme, partial degree programme or subject area; scholarships may be awarded jointly for several degree programmes or partial degree programmes (cluster). ²Scholarships may be awarded separately for each type of applicant as defined in appendix 1 or jointly for several types of applicants as defined in appendix 1. ³The faculties shall draw up a ranking list in accordance with the above provisions and thereby make a preliminary selection; a selection committee shall be responsible, consisting of the Dean of Studies and one member each of the university teachers' group, the staff group, the MTV group and the students' group.

(7) ¹The scholarships to be awarded freely shall be distributed evenly among the faculties, taking into account the scholarships to be awarded for a specific purpose. ²The share of each faculty shall be determined by the share of a faculty in the total number of study cases of the study programmes whose students are eligible for funding; in the case of study programmes which include independent partial degree programmes supported by different faculties (e.g. two-subject Bachelor's degree), the allocation of the study cases to the faculties shall be

carried out proportionally. ³The maximum limit applicable to the university as a whole pursuant to § 11, section 4, sentence 1, StipG shall apply accordingly to the individual faculties.

§ 8 Approval

(1) ¹The Presidential Board or the institution commissioned by it shall approve the scholarships on the basis of the preselection by the faculties for an approval period of one year; if a scholarship ends or is revoked before the end of the approval period, the scholarship may be transferred for the remainder of the approval period to the highest-ranking applicant who has not yet received a scholarship. ²In the Göttingen Medical School, the decision shall be made by the Board of Directors. ³If there is an important reason, in particular a violation of legal regulations, the pre-selection may be deviated from; the faculty administration of the relevant faculty shall be informed of this.

(2) In order to avoid inadmissible double funding, the University of Göttingen shall ensure by means of a query among the selected scholarship holders that they do not receive any other talent- and performance-related material funding pursuant to § 4 section 1 in conjunction with §1 section 3 StipG.

(3) ¹The granting of a scholarship includes the decision on the grant period, the amount of the scholarship and, if necessary, the duration of the funding. ²The notice of approval specifies the exact date by which a scholarship holder must submit declarations or by which further documents must be received or submitted.

(4) ¹The payment of the scholarship requires that the scholarship holder is enrolled at the University of Göttingen. ²If the scholarship holder transfers to another university during the award period, the scholarship will continue to be paid for one semester in accordance with the previous award, provided that the scholarship holder was enrolled at the University of Göttingen for the majority of the semester. ³Application for another scholarship at the new university is possible.

(5) ¹The scholarship shall not be paid out until the notice of approval has become final. ²The scholarships shall be granted retroactively to 1st October of each year, if necessary.

§ 9 Termination; Interruption

¹The scholarship ends, without the need for revocation, at the end of the month in which the scholarship holder

- a) has successfully completed the course of study (for the purposes of this provision, this is the case when this overall result of the intended degree has been communicated to the scholarship holder, at the latest, however, at the end of the second month after the month in which the last required examination performance was achieved),
- b) dropped out of university,

- c) has changed the degree programme or partial degree programme, or
- d) is exmatriculated.

²The scholarship shall also end when the maximum funding period is reached or eligibility for funding ceases. ³If the scholarship holder changes institutions of higher education during the award period, the scholarship ends at the end of the semester for which the scholarship continues to be paid in accordance with § 8 section 4.

(2) ¹During a leave of absence (with the exception of a leave of absence for a study visit abroad) within the meaning of the ImmaO, the scholarship shall be interrupted. ²With the continuation of studies following the leave of absence, the scholarship shall be continued for the remainder of the appropriately adjusted award period.

§ 10 Withdrawal

(1) ¹The award of the scholarship shall be revoked if the scholarship holder

- a) receives further funding in contravention of § 4 section 1 StipG, or
- b) has obtained the grant by providing incorrect or incomplete information.

²In these cases, a retroactive revocation shall be pronounced.

(2) The award of the scholarship shall be revoked with at least six weeks' notice to the end of a calendar month if the scholarship holder

- a) violates duties to cooperate, or
- b) violates other obligations.

(3) A claim for repayment exists irrespective of whether the grant amount has already been used or consumed in whole or in part.

§ 11 Final provisions

(1) The Department for Student and Academic Services and the Public Relations Department shall report annually on the scholarship programme as part of the annual report of the Presidential Board.

(2) This guideline shall enter into force on the day following its publication in the Official Announcements of the Georg-August-Universität Göttingen.

1. General principles of procedure

1.1. Composition of the initial score

The final grade can be composed of several partial grades in accordance with the following provisions; in this case, the final grade is calculated from the correspondingly weighted arithmetic mean of the individual partial grades. Credits are referred to as (C) in the following.

1.2. Calculation of the total access entitlement

a) The grade of the overall entrance qualification is calculated in accordance with the following provisions and appendices 5 and 6 from the correspondingly weighted arithmetic mean of the grade points or the grade of the degree conferring the higher education entrance qualification (HZB) and the individual grade points or grades of the teaching subjects relevant for the chosen field of study.

b) The grade points or grades for each subject are calculated from the arithmetic mean of the grade points or grades shown in the HZB certificate in the last four school semesters. If the relevant subject has not been taken in at least one school semester in the last four school semesters, 0 grade points or the grade 6 are used for this subject.

c) The grade of the overall entrance qualification is, if possible, first calculated in grade points and then converted into a grade according to appendix 5 clause II.; if the value after the conversion is less than 1.0, the grade of the overall entrance qualification is 1.0.

1.3. Conversion

a) The conversion of the total number of points of an HZB degree into grade points is carried out in accordance with appendix 5 clause I., grade points into grades is carried out in accordance with appendix 5 clause II., assessments of an HZB degree or a subject in text form into grades is carried out in accordance with appendix 5 clause III.

b) Foreign grades are to be converted into German grades according to the guidelines of the KMK.

The total score is converted into grade points according to the following formula: Points / 60 = grade points.

2. General higher education entrance qualification (Abitur) (840 points)

The total score is converted into grade points according to the following formula: Points / 56 = grade points.

3. University of Applied Sciences entrance qualification (Fachhochschulreife) (285 points)

The total score is converted into grade points according to the following formula: Points / 19 = grade points.

4. In the case of clauses 1.-3., there is no rounding. A maximum of 15 grade points can be achieved.

II. Conversion of grade points into grades

The grade points according to clause I are converted into grades according to the following formula: (17 - point value) / 3 = grade.

III. Conversion of assessments of an HZB degree or a subject in text form into grades

If the assessment of an HZB degree or of a subject is only available in text form and if it is impossible or unreasonable for the applicant to obtain a conversion into grade points or grades from the issuing authority or educational institution, the assessment shall be checked to see whether one of the following grades can be derived from it with reasonable effort:

- 1 = very good = an outstanding performance
- 2 = good = a performance that is significantly above the average requirements
- 3 = satisfactory = a performance that meets average requirements
- 4 = sufficient = a performance that still meets the requirements despite its deficiencies
- 5 = hardly sufficient = a performance that no longer meets the requirements due to significant deficiencies
- 6 = insufficient = a performance which, due to serious deficiencies, does not meet the requirements and at best reveals incomplete basic knowledge.

In the case of differentiated assessment, intermediate values can be formed by decreasing or increasing the grades by 0.3; the grades 0.7, 4.3, 4.7, 5.3 and 5.7 are excluded.
